Deborah also serves as the Governor's liaison to the Department of Insurance, Financial Institutions and Professional Registration and as the Governor's designee to the Missouri Workforce Investment Board. She previously served as liaison to the Department of Health and Senior Services.



From 2004 to 2009 Deborah worked as an assistant attorney general prosecuting civil and criminal consumer fraud cases in the Missouri Attorney General's Office. She also served as an adjunct assistant professor at Saint Louis University School of Law. Confirmations must be made within first month of session

Most recess appointments must be confirmed by the Missouri Senate when the legislative session convenes on Jan. 5, 2011. If your appointment requires Senate confirmation, you must attend a confirmation hearing within 30 days of the start



of session to continue serving. Your state senator must sponsor you at this hearing.

The B&C staff will contact you in January 2011 about your hearing date and details on a reception to be held on the morning of your hearing.

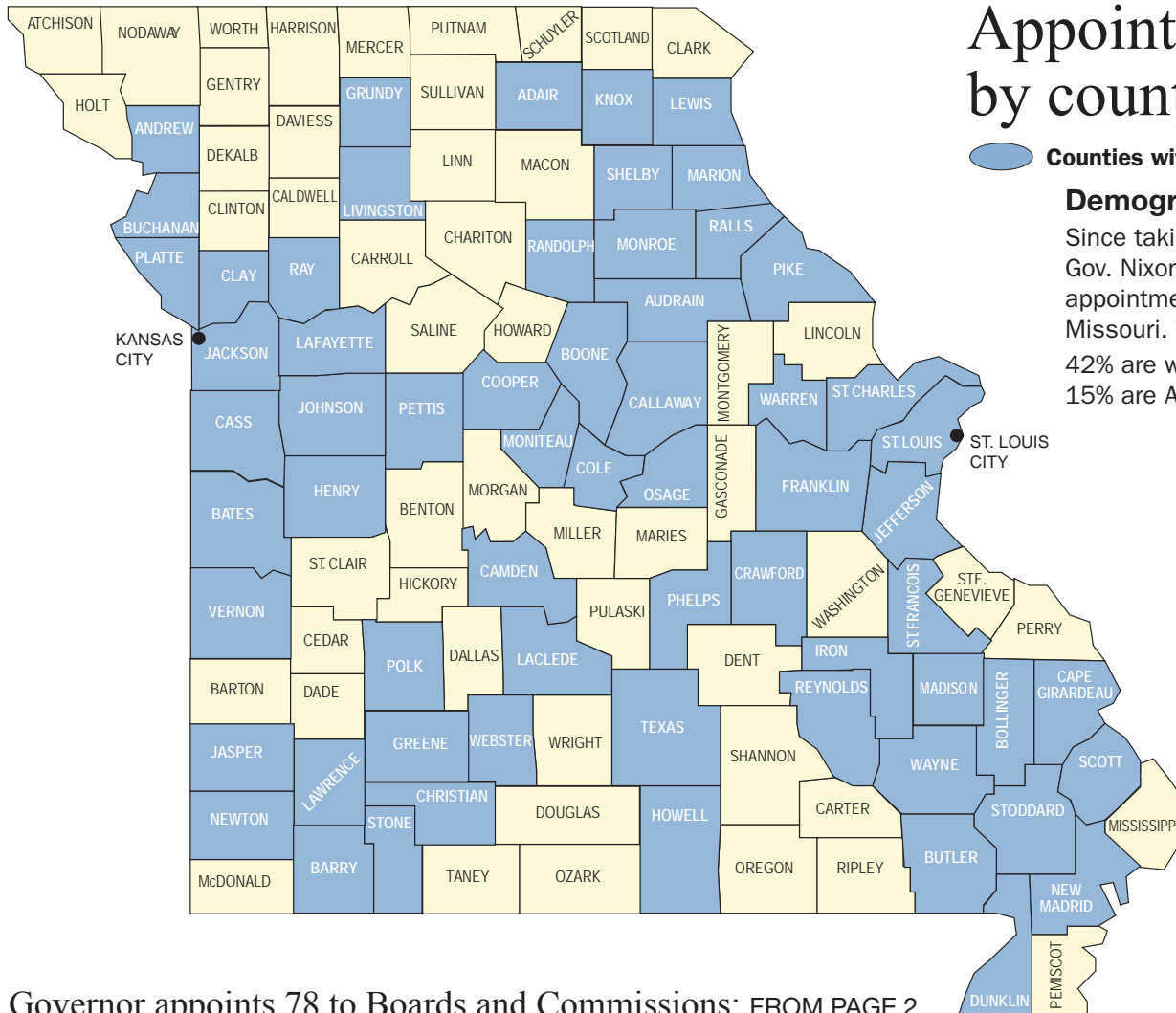

Agency Spotlight: Children's Trust Fund

YOU PROBABLY know them best by the familiar license plate that is Missouri's most popular specialty plate. But there's a lot more to the Children's Trust Fund, which for the past 27 years has been educating the public and awarding grants, all in the name of preventing child abuse and neglect in Missouri.

The CTF staff, led by its 21-member board of directors, was established by the legislature in 1983 to prevent child abuse and neglect through grant distribution, education and public awareness.

No state funding

The agency receives no general revenue. Funding comes from fees on marriage licenses and vital records, sales of the CTF license plate, voluntary contributions designated on state income tax returns, other donations and interest income from the fund.

Established: 1983

Purpose: Prevent and alleviate child abuse and neglect

Number of board members: 21

Term length: 3 years

FY 2010 budget from fees and donations: \$2.97 million

27 years of giving: Since CTF's inception, over \$45 million has been distributed to support Missouri's children and families. Recipients throughout the state include schools, counties, courts, health departments, law enforcement, child advocacy groups and hospitals.

Education, prevention programs

The board invests nearly \$3 million a year in public education campaigns and prevention programs, including grants for:

- Safe cribs and infant nurturing
- Parent education and mentoring
- Caregiver support
- Home visitation
- Crisis intervention, respite care
- Staff training, development
- School- and community-based education

The board annually awards more than 100 of these grants to community-based organizations, which reach well over 80,000 people each year.

“Research shows that every dollar invested in these prevention programs can save \$7 to \$18 in future expenses related to child abuse and neglect,” says Executive Director Kirk Schreiber.

Public education, awareness

You may have heard CTF’s public education messages, including radio ads and billboards, on the prevention of shaken baby syndrome, safe sleep environments, positive parenting, emotional child abuse and neglect, and the dangers of leaving children unattended in and around vehicles.

CTF is the first Children’s Trust Fund nationally to engage in social networking by using podcasts and Twitter. It has more than 1,500 followers on Facebook.

Getting results

Measuring specific outcomes including satisfaction of services received is an important requirement of CTF grants. Overall, families enrolled in prevention programs report high levels of satisfaction. Data show a significant reduction in family risk and parent stress among participating parents.
